The petitioner may choose anyone on this roster as a panelist for a peer hearing or arbitration.

The University selects a panelist as well, but the University's selection is not limited to any particular roster. The members of this roster are appointed by representative employee committees and serve terms of up to three years. (The year a panelist's term ends is in brackets.) The policy requires that panelists not have a direct interest in the dispute and that they serve as neutrals, regardless of who selected them.
